**Law & Public Defense 2026 Opportunity:** Cornell University's Office of Academic Diversity Initiatives, Cornell Law School Career Development Office, Cornell Career Services, the NYS Office of Indigent Legal Services, and the Tompkins County Office of Assigned Counsel are partnering on a summer academy offering training and paid public service internships for Cornell undergraduates and law students. The ten-week program includes two weeks of training followed by internships with trial lawyers representing indigent individuals in upstate New York. Students will gain hands-on experience in case investigation, legal research, motion practice, and courtroom proceedings, with a focus on criminal defense and family-related matters.

**EXCELSIOR FELLOWSHIP:** The New York State Excelsior Service Fellowship Program is a paid two-year fellowship offering talented graduate, law, and advanced degree program graduates unmatched training and experience in New York State government. Excelsior Fellows work full time at host executive-branch agencies and authorities, advancing the operational and legal aspects of important policy initiatives. Fellows will also participate in a Professional Development program focusing on leadership development and the fundamentals of New York State government.

After completing the Excelsior Service Fellowship, exceptional fellows may continue to serve New York State. More than 50% of prior classes of Excelsior Fellows were offered permanent positions with the State post-fellowship. Applications will be due on **February 28, 2026 with interviews scheduled on the Cornell campus on March 24 and March 25, 2026**

The personal statement should outline your interest in the Excelsior Service Fellowship and your commitment to public service (no more than 750 words).

**A Message from the Dean Akyea:** Networking in the U.S. is less transactional than you may expect. Informational conversations are not favors; they are the currency of the legal market. Students who schedule steady, low-pressure conversations can have great outcomes. Think of the LLM year as a one-year professional residency. Every class, activity, and conversation should ladder up to a coherent story: *What kind of lawyer am I becoming, and where does my international background add value?* And do not undersell your prior experiences such as Multijurisdictional thinking, cultural adaptability, and facility with comparative regulatory systems. **Final Thought:** Ask people about their practice evolution, not job openings. Lawyers remember thoughtful questions. They forget cold requests.

## 2Ls & 3Ls

On Tuesday, January 20, at 8:00 a.m. EST, all 2Ls received **read-only access to OSCAR**, the Online System for Clerkship Application and Review. OSCAR is a tool which federal judges may use, if they wish, to publicize and/or accept clerkship applications.

**MoloLamken's Advocacy Academy:** MoloLamken's Advocacy Academy is a one-week, intensive trial and appellate advocacy boot camp in New York City being held 8/2-8/7 2026. The firm covers travel and hosts the full program, with small-group trainings led by firm attorneys. Name partners Steve Molo and Jeff Lamken personally participate. Only 12 students nationwide are selected each year, typically including one Cornell student. The Academy is designed to complement a summer internship and takes place at the end of the summer. Participants receive a \$4,500 stipend. Students pursuing public interest or public defense are encouraged to apply—Big Law is not required. Last year's Cornell participant, [Avery M. Newcom](#) was committed to public defense and is available to answer questions.
